Content	Within the scope of the course, firstly, the professions that can be performed after graduation are introduced. Afterwards, students who have fulfilled the requirements related to the internship within the scope of the Turkish-German University Faculty of Law Internship Elective Course Practice Principles give presentations on two files that they have examined and reported. These files should be such that students can present their analysis and evaluation of legal issues during their internship. In addition, events such as court/institutional visits and interviews with lawyers are held. Thus, it is ensured that students gain professional experience before graduation and have foresight about career planning.
