### VIII – Required Documents for Registration:

1. The original graduate diploma or the graduation certificate approved by the graduated university must be submitted. Candidates who have graduated from foreign universities must submit their diploma or graduation certificates in Turkish translation by a sworn translator and notarized by the notary or by the consulate.
2. The notarized or by the graduated university-approved transcript of records including all courses taken during the study. Candidates who graduated from foreign universities must

- submit their transcripts in Turkish translations made by sworn translators and notarized by the notary or by the consulate including the GPA.
3. Candidates who apply from the Turkish applicant quota must submit the ALES score internet printout or original result document of an equivalent exam.
  4. YÖKDİL, YDS, or e-YDS score internet printout or original result document of an equivalent exam.
  5. Foreign applicants including Mavi Kart holders and Turkish citizens with a foreign bachelor's degree must submit a recognition certificate prepared by the Turkish Higher Education Council (YÖK) or taken from E-Devlet (<https://www.turkiye.gov.tr/>).
  6. Showing the identity card during registration is sufficient.
  7. For foreign citizens -if existing- a copy of residence permission and foreign citizen identity card number.
  8. Copy of the related pages of the passport for foreign citizens showing validity period and identity information. (With existing residence permit no student visa is required)
  9. Turkish citizens should submit a document indicating that they are not affiliated with the military service.
  10. Turkish citizens who are research-assistant at our university or other universities should submit an official document received from their institution.

**NOTE:** The registration of applicants making false statements and with deficiencies or falsifications in their documents are not possible. Even if the registration has been done, the registration is canceled.

#### **IX – Tuition Fee:**

The Business Management Master's Thesis Program is an **evening education** program and is **subject to tuition**. In the academic year 2021-2022;

- a) The students will be entitled to enroll from Turkish student quota will be charged a fee of 60 TL per credit point is going to be charged.
- b) The students who will be entitled to enroll from international student quota will be charged as three times of that amount.

**The registration is only possible with the original or certified copies of ALL the required documents.**
