1	The factors that emerged in the formation of the 1858 Criminal Code						
2	The acts punished in the 1858 Penal Code: The distinction between murder, junha and misdemeanor						
3	Penal sanctions against murders: Death penalty, Rowing penalty, Exile penalty (temporary and life exile), Deprivation of civil rights						
4	Penalties against junha and misdemeanors: Imprisonment, temporary exile, suspension from duty, fines, temporary deprivation of civil rights						
5	Crimes against people; murder, injury, batter, threatening						
6	Murders and junhas violating the external security of the state, crimes violating the internal security of the state: Incitement to revolt, crimes against the Sultan's personality, arson, etc.						
7	Bribery crime, 'raşi' and 'mürteşi'						
8	Stealing state property, abuse of office and duty						
9	Offenses of opposing, disobeying and insulting government officials						
10	Hiding criminals and helping prisoners escape, removing seals placed by authorities						
11	To pretend to be a civil servant, to block recognized religious privileges, to destroy communication facilities, to open a printing house without permission						
12	Counterfeit money printing, fake signatures, official documents and documents fraud						
13	Self-defence, abortion, crimes against honor and dignity
