### II. QUOTA

- Foreign applicants with Turkish citizenship who have completed their education abroad can apply from the ***Abroad Quota***,
- Applicants who completed their education in Turkey must apply from the ***Domestic Quota***,

### III. STUDENT ADMISSION REQUIREMENTS

Candidates must meet the requirements marked for the type of quota they are applying for.

<b>1. Graduation from Higher Education</b>  As of the application date, candidates must have a master's degree in law or be a student in the thesis period of their master's degree for conditional acceptance.	✓	✓

<p><b>2. ALES</b></p> <p>Candidates who have completed their higher education in Turkey must have an ALES score of 70, which is the minimum score determined in at least one of the SAY, SÖZ or EA score types. (The validity period of the ALES Result Certificate is 5 years).</p> <p>Doctorate / proficiency in art / specialization in medicine / specialization in dentistry / specialization in dentistry / specialization in veterinary medicine / specialization in pharmacy graduates are not required to take ALES and the ALES score of candidates with these degrees is accepted as 70. These candidates can apply in a different field than the type of score they previously received or the field of doctorate / proficiency in arts / specialization</p> <p><b>Applicants applying from abroad</b> are exempted from ALES. However, <b>foreign applicants who have completed their education in Turkey</b> must have a minimum ALES score of 70, which is the minimum score determined in at least one of the SAY, SÖZ or EA score types.</p>	✓	x
<p><b>3. Foreign Language Proficiency</b></p> <p>Candidates must certify their level of German language proficiency; 70/100 YDS (or an equivalent exam result).</p> <p>(The validity period of YDS, e-YDS and YÖKDİL Foreign Language Exams is 5 years).</p> <p>For applicants who apply with a German language certificate, DSH2 or DSH3 certificate is accepted. #### **IV. ASSESMENT CRITERIA**

The evaluation of the applications is carried out according to the following distribution. In order to be accepted to the program, a minimum score of 70 (seventy) is required.

\* For applicants who do not have a master's degree as of the application date, the transcript grade of the last (current) semester is taken into consideration.

After the evaluation of the applications, the results will be announced on <http://sbe.tau.edu.tr/>. In addition, an acceptance letter with electronic signature will be sent to the accepted candidates via e-mail by the Institute of Social Sciences of our University.

#### **V. DOCUMENTS REQUIRED FOR APPLICATION**

Applications will be made only electronically via the link [https://obs.tau.edu.tr/oibs//ina\\_app/](https://obs.tau.edu.tr/oibs//ina_app/) between the specified dates.

Candidates are required to upload the information and documents required for the application to the system within the deadlines specified above.

Applications made by mail or in person will not be accepted.

The following application documents must be uploaded to the application system in .pdf format.

<b>f) Bachelor's and Master's Degree Diploma or Provisional Graduation Certificate</b>  It is sufficient for applicants to document their graduation. Candidates who are in the last year of their master's degree and candidates applying from abroad can apply with a current transcript.  Early conditional applicants must submit a current student certificate stating that they are a student in the last semester of their master's degree instead of a master's degree diploma.  <b>Candidates who cannot graduate before final enrollment date will not be registered even if they have won as main student.</b>	✓	✓
<b>g) Transcript:</b> <i>Transcripts of candidates applying from abroad must be issued in English or German.</i>	✓	✓
<b>h) Foreign Language Certificate:</b>  YDS, e-YDS, YÖKDİL or a DSH2 or DSH3 certificate or an exam result document accepted by ÖSYM and showing German language proficiency equivalent to at least 75 points, or an exam result document equivalent to this level of an exam conducted by the Turkish German University.  <i>Except for candidates who have completed their studies abroad in a department teaching in German.</i>	✓	✓
<b>i) ALES</b>  Candidates who are applying from the domestic quota must submit the original ALES document with the "Result Document Control Code" or the original of the equivalent exam result certificate accepted by YÖK.	✓	✗
<b>j) Recognition of Foreign Higher Education Certificate:</b>	✗	✓

The "Certificate of Recognition" to be obtained from the Council of Higher Education (YÖK) is mandatory for foreign applicants (including students with blue cards) who will apply for graduate education and for Turkish national applicants who have completed their education abroad.

Turkish national candidates can access the necessary information on whether their higher education institutions abroad are recognized by the Council of Higher Education (YÖK) and the school recognition letter via [e-government link](#).

Foreign applicants and students with blue cards can access the necessary information on whether the higher education institutions abroad are recognized by the Council of Higher Education (YÖK) and the school certificate of recognition via the [YÖK link](#).

In case the higher education institutions abroad are not recognized by YÖK, the information and processes required for the application can be accessed via the [YÖK link](#).

## **VI. KAYIT İÇİN GEREKLİ BELGELER**

- 1) Original bachelor's and master's degree diploma or graduation certificate approved by the University of graduation,

A notarized or certified copy of the transcript showing the grades of all courses taken during undergraduate and graduate education and the graduation grade point average from the relevant higher education institution is required,

- 2) Candidates applying from the domestic quota must submit the original ALES document with the "Result Document Control Code" or the original of the equivalent exam result document accepted by YÖK,

Candidates who have graduated from higher education institutions abroad must submit their transcript documents with a Turkish translation made by a sworn translator and notarized or consular certification and including their grade point average.

- 3) Candidates applying from the domestic quota must submit the original ALES document with the "Result Document Control Code" or the original of the equivalent exam result document accepted by YÖK,
- 4) Original YDS, E-YDS or YÖKDİL document with "Result Document Control Code" or original foreign language exam result document accepted as equivalent by YÖK or original DSH2 or DSH3,

- 5) "Certificate of Recognition" to be obtained from the Presidency of the Council of Higher Education for foreign applicants (including students with blue cards) and Turkish national applicants who completed their education abroad,
  - 6) It is sufficient to show the original identity card during registration.
  - 7) For foreign nationals -if any- a photocopy of the residence permit and a document showing the Foreign National Number.
  - 8) For foreign nationals, a photocopy of the pages of the passport showing identity information and validity period
  - 9) Bank receipt of the payment of the student contribution / tuition fee determined by the relevant legislation for candidates applying from the quota abroad,  
Graduate student candidates who are accepted from abroad quota must pay **three times the specified contribution amount.**

- 10) A military service status certificate showing that the candidates of Turkish nationality are discharged from compulsory military service.
  - 11) For candidates of Turkish nationality who are research assistants at our university or other universities, an official document from their institutions.

**IMPORTANT:** Candidates should not be enrolled (at the same time) in more than one doctoral program at the time of registration. (Candidates should not be enrolled in more than one doctoral program at the time of registration) Candidates in such a situation can only enroll in our Institute if they deregister from the other higher education institution.

**NOTE:** For those who make false/incorrect statements and those whose documents are incomplete or falsified final registration won't be made, and even if they made their final registration, their registration will be canceled.
