Objectives	In addition to the main courses of criminal law, it would be useful to include a course that examines the decisions of the supreme court according to their subjects at the graduate level in the curriculum. Such a course would be an advantage for students in their professional life.			
Content	Supreme Court Decisions in Criminal Law is a course in which the decisions of the Supreme Court, the Constitutional Court and the European Court of Human Rights on criminal cases or applications are examined according to their subjects. The course consists of three main parts. In the first part, the decisions of the Turkish and German Court of Cassation, which solve the basic problems in the fields of general and special provisions of criminal law and criminal procedure law, are discussed comparatively. The second part deals with the decisions of the Constitutional Court and the third part with the ECHR on the applications filed with the claim of violation of rights in criminal proceedings.
