Objectives	The aim of the lecture is to explain the procedure on execution (with or without a court ruling) as well as the types of execution.					
Content	The following subjects will be dealt with in the course: Introduction to enforcement law and organization of the debt collection agencies (supervisory authorities, courts and tribunals), the sources of enforcement law, complaint, parties of compulsory execution and joinder of enforcement, executive notification, types of execution Proceedings in general, attachment (request for execution proceeding, execution office, objection against enforcement proceeding and removal of the objection), declaring property, negative declaratory action and action of restitution, the concept of attachment in general and participation to an attachment, procedure of encashment, tender and termination of tender, an action of replevin, certificate of insolvency, foreclosure, enforcement of attachment peculiar to bills of exchange, an enforcement proceeding, evacuation of leased immovables via enforcement without judgment and provisional attachment. During the semester, practice exams will be analyzed in the course to clarify these subjects.
