Objectives	The aim of this course is to comprehend the conditions and procedures of the bankruptcy proceedings which will be made to cover all of the debtors’ assets.					
Content	Within the scope of the Bankruptcy Law course, attachment proceedings specific to bill of exchange, pursuance proceedings through foreclosure, general informations about bankruptcy law, pursuance proceeding through ordinary bankruptcy, bankruptcy case, legal consequences of the opening of bankruptcy, bankruptcy and liquidation procedure, examination of the creditors and determination of the payment order, closure of bankruptcy, bankruptcy proceedings specific to bill of exchange, bankruptcy without proceeding, postponement of bankruptcy, concordatum (ordinary concordatum, in-bankruptcy concordatum and cessio bonorum), reconstruction of the companies with share capital and the cooperatives with negotiation and the cancellation of possession trial will be discussed and practical studies will be carried out to reinforce these issues.
