The Turkish-German University

The Turkish-German University (TDU) in Istanbul is a state university founded on the basis of an intergovernmental agreement between the Republic of Turkey and the Federal Republic of Germany. It is currently the most ambitious project of Turkish-German scientific and educational cooperation. More than 4,000 students study and research at five faculties and a language center. The TDU is supported by a German university consortium consisting of 38 member universities and the German Academic Exchange Service (DAAD).

Faculty of Law

The Faculty of Law of the Turkish-German University is dedicated to teaching and research in the field of law and its application in a national, European and international context. The focus is on the law in force today. Its historical, cultural,

economic and social aspects are integrated and geared towards the practical needs of legal life. The Faculty of Law, which cooperates with the Free University of Berlin on the German side, places a special focus on legal issues of particular importance for Turkish-German relations and legal development.

Objectives of the degree program

The Bachelor's degree program in Law is a four-year program aimed at students with Turkish and German language skills. The program combines the traditions of Turkish legal education with a German, European and international orientation. We place particular emphasis on case-related legal application practice in order to train the ability to analyze and argue legal problems as core competencies of legal education at an early stage. In addition, we offer our students the opportunity to choose from various elective subject groups, enabling them to focus on a particular area of specialization. Our innovative concept is characterized not least by its multilingualism: Around a third of our law courses are held in German and are accompanied by subject-specific foreign language teaching.

Study building

The Bachelor's degree in Law requires the acquisition of 240 ECTS credits. In order to prepare students for German-language teaching at the Faculty of Law, a one-year German course at the Center for Foreign Languages at TDU precedes the four-year degree course

TEN REASONS FOR STUDYING LAW AT TDU

1. Bilingual studies

The Turkish-German University is the only state university that offers an additional course in German law alongside a fully-fledged Turkish law degree.

2. Reputable scientists and scholars

The faculty of the Faculty of Law consists of Turkish and German academics who are recognized experts in their respective fields.

Our practice-oriented education system combines the best achievements of the Turkish and German education systems.

Our students are particularly well qualified to start their careers in an international environment. The Bachelor's degree also enables them to participate in postgraduate courses such as the law Master's programs at TDU.

Electives equip our students with in-depth legal expertise and a special qualification for Turkish-German and European legal life.

6. Study visits to Germany

Study visits to Germany are funded by scholarships from the German Academic Exchange Service (DAAD) and the Turkish Higher Education Council (YÖK), depending on performance and capacity.

7. Outstanding care rate

The number of our students is deliberately kept low compared to other universities. This results in an excellent ratio of teaching staff to students.

8. Optimal teaching conditions

The campus is quiet, spacious and surrounded by numerous green spaces. The university buildings are characterized by modern architecture and are built using state-of-the-art technology.

9. Diverse research opportunities

The Faculty of Law at the Turkish-German University conducts a wide range of studies relating to both the Turkish and German legal systems.

10. Involvement in numerous extracurricular activities

Both the Faculty of Law and our students are very active and are involved in numerous extracurricular activities at TDU.
