Content	<p>Within the scope of this course;</p> <ul style="list-style-type: none"> - Details of the Turkish Revolution, which constitutes the founding philosophy and basic principles of the Republic of Turkey, - Internal developments in İsmet İnönü Period and the effects of World War II on Turkey and the world, - Transition to multi-party life and Demokrat Parti years, which are extremely important for Turkey's political history, - The effect of the new world order, shaped by the influence of the cold war in the world, on Turkey's internal and external dynamics, - Internal and external developments in the period between the two military interventions, - The years of civil democracy with Turgut Özal after the 1980 Military Intervention, - Coalitions period between 1991-2002 in Turkey, - The political, social and economic developments from the establishment of the Adalet ve Kalkınma Partisi in 2002, which will mark the last twenty years of Turkish political life, will be discussed.
